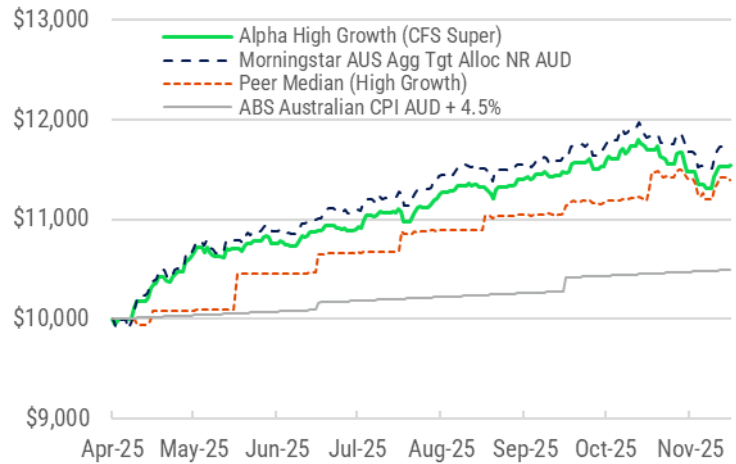

Performance Over Time

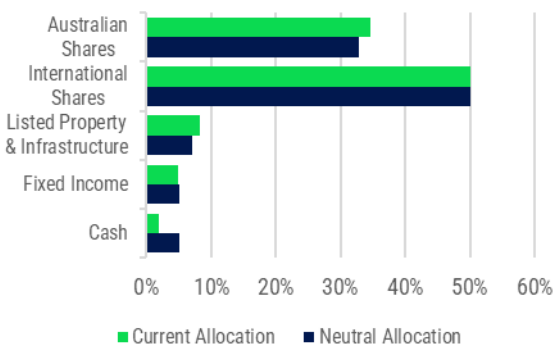
